Opening of new Self-Financing Courses in PPP Mode-regarding

Sir,

In inviting a reference to your letter on the subject noted above, I am directed to say that after careful consideration, permission is hereby accorded for opening of new self-financing course on PPP mode in collaboration with the Shantiprava Educational Trust, Ichhapur, Bhadrak from the academic session 2023-24 as indicated below.

1	Bachelor of Computer Application (BCA)	3 years	72	Rs.25,000/- per annum	As per existing norms of the college.

The above courses will run in the College subject to the following conditions:

i.

a. The Principal, Fakir Mohan Autonomous College, Balasore is allowed to open the above self-financing course from the academic year 2023-24 in collaboration with M/s Shantiprava Educational Trust, Ichhapur, Bhadrak by signing MoU with stipulations.

ii. The UGC Guidelines for starting of New Courses in the College shall be followed strictly.

iii. The College will provide space for running the courses but the entire investment for running the courses shall be made by the collaborator.

iv. The revenue sharing shall be at the ratio of 30:70 between the College and collaborator respectively.

v. The resource persons should be selected through a Selection Committee consisting of the Principal, representative of M/s Shantiprava Educational Trust, Ichhapur, Bhadrak and such other experts to be selected by college authority as well as M/s Shantiprava Educational Trust, Ichhapur, Bhadrak.

b. The Government will not provide any funds and staff for running of the above courses.

c. As per UGC guidelines for Colleges, the F.M. University, Balasore shall be duly informed for opening of such Courses and necessary affiliation may be obtained from the University from the year 2023-24.

d. The Principal of the College should be extremely careful for;

i. Proper preparation of courses of studies;

ii. Proper selection of students;

iii. Proper conduct of classes;

iv. Quality teaching; and

v. Maintenance of discipline;

- e. Besides, the amount due to be paid to the Service Provider should be released in installments after proper assessment of their performance.  
f. Principal shall ensure that running of the self-financing courses in no way affect the general teaching of the College.
