Sir,

In inviting a reference to the above mentioned letter, I am directed to say that permission as sought for has been accorded for opening of four (04) new self-financing courses on PPP mode from the academic session 2022-23 as indicated below: -


Sl. No	Name of the Course	Duration (Year)	Seat Strength	Fees in Rs. (Annual)
1	Bachelor in Science and Information Technology Management (B. Sc. ITM)	3	64	50,000
2	M. Sc. Computer Science	2	64	35,000
3	Master in Finance Control (MFC)	2	96	25,000
4	Mater in Business Administration (MBA)	2	96	40,000

The above courses will run in the College subject to the following conditions:

- a. The Principal, F.M. (Auto) College, Balasore is allowed to open the above self-financing courses with from the academic year 2022-23 in collaboration with M/s Association For Development Initiative (ADI), Bhubaneswar by signing MoU with stipulations.
  - i. The UGC Guidelines for starting of New Courses in the Autonomous College shall be followed strictly.
  - ii. The College will provide space for running the courses but the entire investment for running the courses shall be made by the collaborator.
  - iii. The revenue sharing shall be at the ratio of 30:70 between the College and collaborator respectively.
  - iv. The resource persons should be selected through a Selection Committee consisting of the Principal, Representative of M/s Association For Development Initiative (ADI), Bhubaneswar and such other experts to be

- selected by college authority as well as M/s Association For Development Initiative (ADI), Bhubaneswar.
- b. The Government will not provide any funds and staff for running of the above courses.
  - c. As per UGC guidelines for Autonomous Colleges, the Fakir Mohan University, Balasore shall be duly informed for opening of such Courses and necessary affiliation may be obtained from the University from the year 2022-23.
  - d. The Principal of the College should be extremely careful for;
    - i. Proper preparation of courses of studies;
    - ii. Proper selection of students;
    - iii. Proper conduct of classes;
    - iv. Quality teaching; and
    - v. Maintenance of discipline;
  - e. Besides, the amount due to be paid to the Service Provider should be released in installments after proper assessment of their performance.
  - f. Principal shall ensure that running of the self-financing courses in no way affect the general teaching of the College.
- Approval of the Principal Secretary to Government has already been obtained in File No. HE-PTC-POLICY-0004-2022 to the above extent.




